What is College App Week?

College Application Week (CAW) is a concentrated effort to give all high school seniors the opportunity to apply to one or more colleges while at their high school, technology center, library or community center, with knowledgeable volunteers available to help them through the application process.

CAW is part of an initiative sponsored by the Kresge Foundation, the Lumina Foundation and the Bill and Melinda Gates Foundation for the American Council on Education.

Do my CAW activities have to cover a whole week?

No. The most important objective of CAW is scheduling one or more days during the week for students to have computer access for applying to college. Other activities throughout the week help to build excitement and student involvement.
